

## Strategic Recommendations for 2016

Actions the Florida Governor and Legislature can take in 2016 to advance Florida as a global economic leader in ocean and coastal conservation, research, and innovative technology development

## **Recommendation 1:**

Support Florida Ocean Alliance's 2016-2017 funding request for \$300,000 to:

- 1. Update and expand its Florida Oceans and Coasts Economic and Cluster Analysis and
- 2. Work with directed state agencies to develop a proposal for a comprehensive strategic ocean and coastal plan for the State of Florida. The economic analysis will document the economic value of Florida's ocean and coastal industries and natural assets. Creating a proposal for a coastal and ocean plan for the State of Florida will move the State towards its position as a national leader in ocean and coastal stewardship and strategic economic development.

Return on Investment Value – The last Florida Ocean Alliance assessment was completed in 2013 and was reliant on 2009-2011 economic data. The new assessment will capture economic valuation and trends for Florida's ocean and coastal industries and natural resource assets. The assessment will explore economic growth potential for Florida with a vision to position Florida as a national leader in responsible ocean and coastal economic development, conservation, scientific research, and technology innovation. The final report and executive summary will be distributed to the Governor's Office, Florida Legislature, Visit Florida, Career Source Florida Inc., Enterprise Florida Inc., and to the public through the Alliance website (http://www.floridaoceanalliance.org/)

## **Recommendation 2:**

Request that the Florida Ocean Alliance work with state agencies in a public-private partnership to develop a preliminary proposal and cost estimate to prepare and deliver a comprehensive and strategic ocean and coastal plan for the State of Florida. This preliminary proposal and budget will be presented to the Governor and Florida Legislature in August 2016 for implementation consideration and funding during the 2017 Florida Legislative Session.

**Return on Investment Value** – The State of Florida is in a historic position to develop a strategic plan for its ocean and coastal economy that integrates natural resources conservation, economic growth and efficient use of available economic resources to restore and sustain its valuable water and coastal resources. A comprehensive, statewide planning process would establish a vision for Florida's ocean and coastal future, help decrease stakeholder use conflicts, identify innovative partnerships (e.g. coupled space and ocean research and technology development), and help cultivate a brand for excellence that will diversify and grow Florida's ocean and coastal industry clusters and jobs.
